Instructions

Just fill out the Coastal Vacation Payment Plan application completely, be sure to sign and date it. Mail to N.B. Management with a \$50.00 processing fee and 1st payment of \$300.00 (total \$350.00) Cashiers Check or Money Order Only.

Your client will receive the Coastal Vacation Package immediately after verifying director information at bottom of application. Clients will receive a payment schedule with Coastal Vacations Package for the additional 3 payments. Failure to make one of these payments will result in default which could possibly lead to the deactivation of your Coastal Vacations Package.

Directors should work with their new clients and guide them into the Coastal System to use all the business building tools in place for them.

Directors will receive a \$300.00 commission payment immediately after each payment has been made, for a total of 3 payments over the 90 day period.

These clients are not to be counted as your two training sales needed to qualify for a director, until all payments have been made. (Over a 90 day period).
